Autonomous learning**Recommendations**

It is strongly recommended for students to have already taken a minimum of six credits in subjects about the Middle Ages or the Early Modern Age.

Competences to be developed

- Learning aptitudes and responsibility (capacity for analysis, synthesis, global perspectives, and practical application of knowledge, decision-making, adaptation to new settings).
- Communication skills (ability to understand and express ideas, orally or by writing in Catalan, Spanish, and a third language, specialised vocabulary, ability to search for, use, and articulate information).
- Acquiring knowledge about universal history (especially social and cultural aspects) and different historiographical sciences and techniques.

Learning targets

Contextual

- Learning to analyse Mediterranean history between the 13th and 18th centuries from a comparative, long duration perspective.
- Understanding lifestyles and customs in Mediterranean countries during the period under consideration, as well as the circulation of people, goods, and ideas, political institutions, the economy, and spiritual practices.
- Examining the historical evolution and the structure of social identities in the Mediterranean during a period of change.
- Understanding the political, economic, and social relations between different Mediterranean territories, in a context of growing human and economic connections.
- Finding the necessary historical references for the management of interculturality in the European context.
- Understanding and presenting critically current research on the cultural and social history of the Mediterranean (13th-18th centuries).
- Improving the mutual relations and internationalization of students.

Thematic blocks

1. Political, economic, and social change between the 13th and 18th centuries and their repercussions.

* Each year, a topic on the culture and history of the Mediterranean world will be chosen to be analysed in this thematic block.

2. Cultural and religious change between the 13th and 18th centuries and their repercussions.

* Each year, a topic on the culture and history of the Mediterranean world will be chosen to be analysed in this thematic block

3. Written, archaeological, and written sources related to the common history of Mediterranean territories.

* Each year, a topic on the culture and history of the Mediterranean world will be chosen to be analysed in this thematic block.

Methodology and teaching activities

Teaching will adopt Blended Intensive Programmes of Erasmus+: Virtual exchange + short-term face-to-face teaching.

1.- Virtual exchange: this online will be carried out in Campus Virtual or the Moodle platform (from 2 April to 16 June 2024).

2.- Face-to-face teaching: 5-day course with theoretical-practical activities (from 17 to 21 June 2024, from 9:30 to 13:30 h), with lessons, research seminars (about ongoing doctoral research) and practical activities (visits to research centres, on 22 June 2024, from 9:00 to 14:00 h).

In Moodle, the students will work with the readings and the introduction of the topic, as a complement to face-to-face lectures. There will be virtual opening and closing sessions, and fora for lecturers and students.

Autonomous work. This will involve following the teaching activities related to the methodology of historical work.

Marking

Running evaluation of three criteria:

- participation in class and tutor meetings (25%);
- participation in the fora open in Moodle (25%);

- Lliurament final, en format d'assaig acadèmic, sobre un dels temes presentats en la assignatura (50%).

L'avaluació única avalua les competències: capacitat d'anàlisi i síntesi, capacitat de comprensió dels elements culturals i socials sobre els processos històrics objecte de l'assignatura i capacitat d'expressió escrita. En l'avaluació única, es liurarà una memòria completa que incorpori, a més de l'assaig acadèmic, un informe per cada jornada presencial del curs, tot lliurat en la data ordinària de la convocatòria d'avaluació.
